If trade credit is extended to Applicant, Applicant agrees to make all payments in full, in U.S. Dollars, according to the payment terms indicated on Antares Enterprise's invoice. Antares Enterprises reserves the right to decline trade credit to applicant and in the event trade credit is extended to applicant to change or revoke applicant's credit limit on the basis of changes in Antares Enterprise's credit policies or Applicant's financial condition and/ or payment record.
2. In the event it becomes necessary for Antares Enterprises to file suit to enforce payment of past due accounts, such suit will be brought to LA County, California. Antares Enterprises shall be entitled to collection fees, actual attorney fees, court cost and interest at 10% per annum or such other legal maximum rate as is allowed on all amounts found to be due and payable. All purchases are deemed made and payment is due at the principal place of business of Antares Enterprises at Santa Fe Springs, California. This agreement is strictly confidential and is not transferable or assignable without prior written consent of Antares Enterprises.
3. Service charges of 1 -1/2% per month will accrue on all unpaid amounts more than 30 days past due.
4. Financial statements, credit information and information supplied by Applicant or by others on Applicant's behalf shall become part of this credit application and any false or misleading information shall constitute fraud.
5. Even though an individual may have an approved "open account" with Antares Enterprises, the acceptance of any individual order and terms of payment on all sales and orders are subject to the approval of Antares Enterprises.
